## CPT Code Updates - 2024 CPT Code Changes for Testing to Mayo Medical Laboratories

**Notification Date:** 12/14/2023

**Effective Date:** 01/01/2024

**Explanation:** Annual updates to the CPT (Current Procedural Terminology) and HCPCS (Healthcare Common Procedure Coding System) by the American Medical Association (AMA) and Centers for Medicare and Medicaid Services (CMS) require the review and revision of coding for testing services offered.

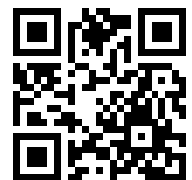
